Dr. Reid, John Foster, and FOIA Officer,

My FOIA request (VFOIA-11079 ) from March 18, 2026 is below. In it, I requested aggregated school-level data on Title IX referrals. On April 10, the deadline date for that request, the FCPS FOIA Office provided me with district-level data. In our fee agreement for \$105, the officer had agreed to provide numbers for the schools and “TS too small” values for the schools under 10 Title IX referrals in any given year to protect student privacy. Therefore, a completed FOIA request would include 597 values (199 schools over three years). The aggregated district totals the FOIA office provided me include only three values. So, you have two choices.

1. Continue to refuse to fulfill my FOIA request, (an admission that you are not complying with FOIA law), and do not charge me \$105.
2. Complete my FOIA request and provide me with those 597 school-level values (Either “TS” or numbers above 10 referrals).

Specifically, I request aggregated, school-level data covering the period from January 1, 2022 through the present, including:

- School name
- Calendar year (or school year, if maintained in that format)
- Total number of Title IX complaints received
- Number of complaints referred to a hearings office or formal adjudication process
- Number of cases resulting in student suspension

I am requesting this information in a raw data format (e.g., Excel, CSV, or similar machine-readable format), if available.

To be clear, I am not requesting any personally identifiable information about students or staff. Aggregated data at the school level will be sufficient.
